Officer Reports

President Report: Announced vacancy of 2nd Vice President on Board and President chose Mary Fowler to fill the term of this position. Board approved unanimously.

Secretary: March 5, 2022 board minutes presented electronically were motioned for approval by Charles Stannard, second by Al MacKenzie. Motion Carried.

Treasurer: reporting Period: 10/1/2021 – 9/30/2022 Account Balances: Checking \$6,622.49; Masters CD \$5,000; and Savings \$8,001.58, Total Assets \$19,624.07. No expenditures made thus far to company contracted to service our Website. Current website postings still being handled in-house.

V.P Bob Comford/Mary Fowler Vice: 2022 Previews ready, 40 sold @ \$3 each. Kay Lynn asked about free copy to Board members approved last year by our Board. President unaware of this Board action, KLD to investigate and report findings. 50/50 sales this season \$200.50. (At the time of transcribing these minutes, Board approved free copy to BOD, Paid Clubs, and Paid advertisers in Nov. 2021).

KOR Nancy Sclafani, 3 move-ups: JoAnn Bryant, Scott Boyd to St. Ams, Karl Clark to PRO.

State Delegate Nancy Sclafani, reported few highlights from FSA October 2022 meeting: Greg Jones appointed as FSA Treasurer, FSA President presented a detailed accounting report of FSA Financials for 2016-2022, to account that all financial records are in order, and along with the audit done for 2021, showed all FSA financial records were found in order.

Comments were made by SWCD members present at today's meeting regarding significant drop in FSA Treasury balances and asked who was held accountable. President Slaughterbeck quieted this discussion, assuring FSA books proved from audit to be in proper order. New Treasurer Greg Jones comes well qualified to oversee the finances for FSA Treasury.

Tournament Entry Fee for 2022-2023 (Item taken out of order under New Business #3)
FSA approved increase to \$10 entry cost for all State Tournaments effective 10/31/22, the \$2 increase fee goes to FSA. Districts can increase to \$10 at their option or leave at \$8 for only District Tourneys. President Slaughterbeck motioned to leave District Tournament entry fee at \$8, seconded by Bob Comford. Discussion: BSC could use the additional monies, others against. Motion by Jerry Stannard to table motion until January 2023 meeting, seconded by John Brown. 11 yays; 9 nays. Motion carried.

Tournament Director Terri Smith - no report

1. (a) No new requests submitted by Clubs so far to host tournaments in 2023-2024 season. Reviewed District holding State/Natl Tourneys as follows: BSC hosting P5, P7, P11A, P13A, P21A, TE hosting: P17A, P20A. President Slaughterbeck motioned to retain District Hosts

for State/National Tourneys as they are on 22-23 schedule for the upcoming 23-24 Season. Seconded by KLDuncan. Motion carried.

- (b) FSA is pushing to hold State Am Tournaments at same time of Pro Tourneys. SWCD Clubs were asked to host St. Am Tournament. No takers. Paradise Bay and BSC hosting State Ams in 22/23 schedule. Request to ask FSA to only schedule one venue on same day as a National Tournament.
